

## Take the next step in supporting your child's education with our Invest in the Vision campaign.

We are grateful to begin this exciting partnership with your family! Each donation made to our school through this campaign helps pave the way for the highest quality education for all students, regardless of background or ability.

### Why does Valor need your financial support?

As a public charter school, Valor South Austin receives limited state funding. Charter schools do not receive local tax revenue and receive very limited funding for facilities. Due to this lack of state and local funding, Valor receives approximately \$2,000 less per student than the average ISD.

Valor works hard to bridge this funding gap by operating with fiscal responsibility. As a result, the deficit between what Valor receives in public funding and what it costs to provide our tuition-free classical education is just over \$1,500 per student.

Through the Invest in the Vision campaign, we ask each Valor family to give as generously as possible. The annual campaign runs from July 1 - June 30 to coincide with Valor's fiscal year. By investing in your child's education at Valor, you are partnering with us to give your child the very best learning environment—one filled with joy, respect, and deep engagement—that develops scholars who are fully alive and filled with wonder.



### How can my family participate?

We encourage you to consider monthly or annual giving. A monthly gift of \$125 per child will help us reach our goal!

### Does my financial gift stay at Valor South Austin?

Yes, the full donation will be used for the advancement of Valor South Austin.

### Is my gift tax deductible?

Yes. Valor is a 501(c)(3) non-profit organization, EIN 81-1122012. All donations are tax-deductible to the fullest extent allowed by law.

### Does Valor receive property tax funding or local tax funding like traditional ISDs?

Charter schools do not receive any local tax money. Local tax money does not follow students but remains with the local district regardless of where the student is enrolled.

### What if we can't participate to the full extent?

Every family's participation, at whatever giving level, makes a difference. Each year, we aim for 100% family participation. However, your child's enrollment is not dependent on contributions to the school.
